**18.027 Apologies for absence:** Mrs A Ashby, PCSO B. Towler, Mr Kier Saunders, and District Councillors: Angela Clear and Therese Evans,

**18.028 The Minutes of the Previous Meeting:** - Proposed Mr. A. Hinton, seconded Mrs P Stallard and unanimously agreed that the Minutes of the meeting held on the 6<sup>th</sup> February 2018 should be signed as a true and accurate record.

#### 18.029 Matters Arising:

- i) Mr Watson asked that matters arising be raised at the appropriate points on the agenda.

#### 18.030 Public Participation:

- i) Mrs Stallard in her capacity as County Councillor had provided a written report see Appendix A. Mrs Stallard in addition to her report added that the leader of the County Council has written to Hampshire's larger local Authorities inviting them to attend a meeting to discuss the areas future.
- ii) Mr Cutler in his capacity as District Councillor reported that at a marathon Council meeting lasting until 2:00pm, Winchester City Council had set its precept increase at 2.9% on a band 'D' property.

He said that he had received complaints about the mobile home site blocking the highway whilst transporting caravans into the site.

- iii) Lt. Col. John gave a verbal update on the staged closure of Southwick Park which as a project has been named Loretta. The first stage which includes the golf course and its surrounding area is already in the process of being returned to private ownership.

Mrs Houghton asked Lt Col John if he could get something done about the drive, which is getting flooded.

Lt Col John asked the Parish Council to write to the MOD.

#### 18.031 Community Safety:

- i) Mr Cutler said that PCSO Towler and the Neighbourhood Watch Liaison Officer had arranged a 'Drop In' session in the Village Café.

#### 18.033 Playing field matters:

- i) Mr Clark said that he has not had time to read the Play Equipment Annual Inspection Report, and asked that this be deferred until the next Parish Council Meeting.

- i) Mrs Houghton reported that Light No.3 in West Street has been damaged and is in need of repair.
- ii) Mrs Stallard suggested that the Parish Council should consider changing to the more economical LED lights.

- i) Mr Watson and Mr Cutler representing the Parish Council went to the Planning Committee meeting to speak on the Phase 13A Development of land's planning application. Mr Watson said that they got an agreement from the Planning Officers to get the proposed number of properties from the Developers.

- i) Mr Cutler said that when the West of Waterlooville Parish Council is created they will expect a share of both Southwick and Denmead's financial reserves. To facilitate the calculation of this he will ask Winchester City Council to provide a breakdown of the proportion of Council Tax paid by the West of Waterlooville over the last three years.

- i) Lt Col John invited the Parish Council to hold a Council Meeting in the Officers Mess at Southwick Park.
- ii) Rev Brocklehurst reported that there had been some thefts of oil from the storage tanks.

It was suggested that this should be taken up with the Estate and Crime Prevention so that people can be alerted.

### 18.030 Public Participation:

#### 1) Helping Hampshire's Local Charities

Across Hampshire there are over 6000 registered charities and many more local groups who offer vital community support to residents across our County - but where do these groups go when they need help? A new resource has been established - the [Hampshire Council for Voluntary Service Network](#) is an alliance of 10 local organisations who work together to provide development services and the specialist skills needed for local groups to grow and meet the challenges facing their local communities.

In a recent survey of their members, over 50% reported an increase in demand for their help from Hampshire residents. Similarly, many charities also report that it is becoming harder to find people who are able to volunteer their time and talents to help. In response, the Hampshire CVS Network has launched a new website that is designed to help local charities and community groups connect with network partners to provide clear and easy access to the skills and resources they need. The site provides access to information on Hampshire's volunteering development services, information on training available across the county and a toolbox of resources for groups and charities that covers everything from transparent and effective governance to raising vital funds to carry out their work. #### 2) Preferred Choice Secondary School

Of the parents applying for a September 2018, Year 7 place at a Hampshire secondary school, 98 per cent have been offered a school of their choice - with more children (over 92 per cent) being allocated a place at their preferred first choice school. The County Council received 13,981 on-time applications this year, up by 428 from last year.

Pupils who did not secure a place at one of their chosen schools have been allocated a place at a school near to where they live, with available spaces. Parents have the right to appeal in these situations and their child's name will be added to the waiting list for their preferred schools. Places do become available if parents change their mind, or families move home. The admissions team is now busy processing primary school applications with offers due to go out to parents on 16 April 2018.

#### 3) Young Musicians

Did you know that Hampshire Music Service supports more than 60 ensembles, orchestras and choirs across the County for young people aged between 5 and 19 years? There are groups for all levels, from beginners trying out instruments, to advanced musicians looking for more challenging material and performance opportunities. The Hampshire Youth Orchestra are preparing for their next big performance, at the Royal Albert Hall in April, in front of an audience of 2,000 people.

#### 4) Council Tax

At full Council held on Thursday 22<sup>nd</sup> February 2018 elected members agreed a 5.99% increase in the council tax precept for 2018/19 (which is made up of a 2.99% core council tax increase which Government now expects all councils to implement, and 3% specifically to support adult social care pressures). Residents in the average band D property will pay £1,200.96 for Hampshire County Council services in 2018/19 – or around £1.31 extra per week.

Hampshire's council tax precept will still be nearly £100 lower than it would have been when measured against inflation since 2010 and remains one of the lowest in the country, whilst still protecting valued services. This has been no mean feat when factored alongside the very tough decisions we have needed to make in order to live within our means given the reduction and eventual removal of the Revenue Support Grant and the £480 m of savings we have to make by 2020.

Despite those challenges and the need to make economies the Cabinet and Conservative group have agreed to save all Hampshire household waste recycling centres, as well as community transport schemes and school crossing patrols. Reductions in these services had been under review but the pressure was eased by an extra 1% council tax increase Government authorised us to make for social care and in the final adjustment of the local government settlement by the Government, when additional funding was allocated to Hampshire. All that helped to offset demands on the budget, although it should be noted that social care costs HCC significantly more than £1 million every day!

#### 5) Recycling Plastic

For a number of years the County Council has worked through various local government networks to lobby and influence central government and the supply chain to re-think the types and amounts of plastics that are used in packaging. Recent publicity [the Chinese government's decision to stop accepting waste plastic and paper from the UK] has been helpful in raising the priority of this issue, leading to its inclusion in the recently published Defra 25 year Environment Plan. The County Council is leading on a project for the HIOWLGA Board that is looking to develop a business case for a new Super MRF that would be able to accept and separate a wider range of plastics than at present. In time, this will lead to an increase in the range of accepted plastics in the kerbside collections carried out by district and borough partners.

#### 6) £3 million Refurbishment Plans

Buildings at three Hampshire schools are to be refurbished as part of a £3 million project to modernise classrooms and reduce energy costs. Work at the Westgate School in Winchester is due to start this summer.

#### 7) £1 million for Leisure Centre

The County Council has agreed to give £1 million towards the cost of a proposed new sport and leisure complex at Bar End, Winchester.

#### 8) Funding for Hampshire's Athletes

Hampshire's most promising athletes have been awarded funding by Hampshire County Council to help them on their journey to sporting success. This year, 191 sportsmen and women have been picked for the Hampshire Talented Athletes Scheme (HTAS), funded by the County Council and managed by Energise Me. Of the 191 athletes awarded support this year, 119 will receive grant funding worth a total of £40,825. The scheme provides athletes with grants for competition and travel costs, physiotherapy and sport science support, free access to leisure centres and bus travel, plus public speaking training to inspire children during school visits. Two former HTAS athletes include Winter Olympic 2018 skeleton racer Gold Medalist, Lizzy Yarnold and alpine skier Laurie Taylor.
