Minutes of Parish Council meeting held Virtually on Tuesday 13th April 2021 at 7:30 pm

21.038 Apologies for absence: Mrs J. Houghton, Mr Clark, Mr T. Parkinson, Mrs P. Stallard, District Councillor T. Evans, Lt. Cmdr. M. Thompson and PCSO B Towler.

21.039 The Minutes of the Previous Meeting: - Proposed Mr A. Hinton seconded Rev. S Brocklehurst and unanimously agreed that the Minutes of the meeting held on the 9th March 2021 should be signed as a true and accurate record.

21.040 Matters Arising:

i) Mr Watson asked that Councillors raise any matters arising at the correct parts on the agenda.

21.041 Public Participation:

- i) Mr Cutler in his capacity as District Councillor:
 - a) He had followed up on Widley Churchyard, and that one of the Estate Managers at Winchester City Council is looking into it.

The Rev. Brocklehurst added that he found the file on Widley Churchyard in his study filing cabinet, the closure order was from the Queens Privy Council and that when this happens, there is never a transfer of land. Statutory notice then is served on the Council to maintain the closed Churchyard. The Rev. Brocklehurst added that the Estate would like to take over the maintenance of the Churchyard if Winchester City Council would give permission.

Mr Cutler said that he would follow this up.

21.042 Community Safety:

a) Mr Watson reported some incidents of drifting.

21.043 Correspondence: The Councillors had received all correspondence before the meeting.

21.044 Playing field matters:

- i) Mr Watson reported that Mr Bailey would commence the work on the Playing Field on Thursday. Mr Watson said that he would ask him to put two stakes across the front as a temporary measure to stop vehicular access whilst the work is proceeding.
 - Mr Watson proposed that an Oak Tree replaces the removed tree.
- ii) The Rev. Brocklehurst said that he had given a progress report on the proposed Playing Field, work to Mark Thistlethwayte and told him that the Parish Council would be getting in touch with him, requesting a grant.

Mr Watson said that he would write to Mark Thistlethwayte.

21.047 Planning Matters:

i) Mr Watson asked what building work Winchester City Council has approved on Cutlers Farm's Planning Application?

- Rev Brocklehurst proposed that three Yew Trees be purchased and planted in the Churchyards as a memorial for Robin Thistlethwayte. He suggested that the Parish Council and D-Day Committee both contribute.
- The Rev. Brocklehurst said that he would investigate this proposal further and report to a future meeting. ii) Mr Watson raised about the Government's decision not to allow virtual meetings after the 6th May.

Mr Cutler reported that there would be a Judicial Review with a decision made before the end of April whether virtual meetings can continue.

The Council decided that if the Judicial Review chose not to allow virtual meetings, the Council would arrange a face to face meeting on Monday 10th May in the outdoor facilities of either the Red Lion or the Golden Lion.
